Exposure controls

10- STABILITY AND REACTIVITY

Reactivity

There are no particular risks of reaction with other substances in normal conditions of use.

DIPHENYLMETHANE-4,4'-DIISOCYANATE

Decomposes at 274°C/525°F.

With water it develops carbon dioxide and forms an insoluble solid polymer and consequently any wet material recovered must be stored in open containers.

Chemical stability

The product is stable in normal conditions of use and storage.

Possibility of hazardous reactions

The vapours may also form explosive mixtures with the air.

XYLENE

Stable in normal conditions of use and storage. Reacts violently with: strong oxidants, strong acids, nitric acid, perchlorates. May form explosive mixtures with: air.

DIPHENYLMETHANE-4,4'-DIISOCYANATE

May react dangerously with: alcohols, amines, ammonia, sodium hydroxide, acids, water, strong acids, strong bases.

XYLENE (MIXTURE OF ISOMERS)

WORKERS: inhalation; contact with the skin.

POPULATION: ingestion of contaminated food or water; inhalation of ambient air.

DIPHENYLMETHANE-4,4'-DIISOCYANATE

WORKERS: inhalation; contact with the skin.

POPULATION: inhalation of ambient air; contact with the skin of products containing the substance.

Delayed and immediate effects as well as chronic effects from short and long-term exposure

XYLENE (MIXTURE OF ISOMERS)

Toxic effect on the central nervous system (encephalopathy); irritating for the skin, conjunctiva, cornea and respiratory apparatus.

DIPHENYLMETHANE-4,4'-DIISOCYANATE

Causes symptoms of irritation of the eye mucous membranes, upper respiratory and digestive tract and also to the skin; lung irritation of the bronchitis type (chest pains, cough, asthmatic wheezing), neurological symptoms (dizziness, balance disorders, headaches and consciousness disturbances).

In severe cases, may give rise to delayed pulmonary edema (INRS, 2009). May cause hypersensitivity pneumonia which, in the event of continuous exposure, may progress to interstitial fibrosis (INRS, 2009).

Interactive effects

XYLENE (MIXTURE OF ISOMERS)

Intake of alcohol interferes with the metabolism of the substance, inhibiting it. Ethanol consumption (0.8 g/kg) before a 4-hour exposure to xylene vapours (145 and 280 ppm) causes a 50% reduction in the excretion of methyl hippuric acid, whereas the concentration of xylenes in the blood increases approx. 1.5-2 times. At the same time there is an increase in the secondary side effects of the ethanol. The metabolism of the xylenes is increased by phenobarbital and 3-methyl-colantrene type enzyme inducers. Aspirin and xylenes mutually inhibit their conjugation with the glycine, which results in a decrease in urinary excretion of methyl hippuric

acid. Other industrial products can interfere with the metabolism of xylenes.

DIPHENYLMETHANE-4,4'-DIISOCYANATE

Cross sensitisations with other isocyanates are possible, in particular with TDI (toluene diisocyanate).
